To ensure that the anti – ragging committees shall conduct such enquiry observing a fair and transparent procedure and the principles of natural justice and after giving adequate opportunity to the student or students accused of ragging, and the other witnesses to place before it the facts, documents

and view concerning the incidents of ragging and considering such other relevant information as may be required.

To monitor, direct and oversee the function and performance of the anti ragging subcommittee in prevention and curbing of ragging in the institution.

## **Ragging - An offence**

Ragging in any form, in any place or time is a cognizable offence that will attract severe punishment including summary expulsion from the college/University/Institution. Extract of Uttar Pradesh Government.

1. In this act, unless the context otherwise requires 'Ragging' means display of noisy, disorderly conduct, doing any act which causes or is likely to cause physical or psychological harm or raise apprehension of fear or shame or embarrassment to student in any educational institution and include.

- a. Teasing or abusing or playing practical jokes on or causing hurt to such students.
- b. Asking the students to do any act or perform something which such students will not, in the ordinary course, willingly act or perform.

2. Ragging within or outside the institution is prohibited.

3. Any student convicted of an offence under section 4 shall also be dismissed from the institution and such student will not be admitted in any other educational institution.

4. Without prejudices to the foregoing provision, whenever any student complains of ragging to the head of the educational institutional or to any other person responsible for the management of the educational institution shall enquire into the same immediately and if found shall suspend the student who has committed the offence from the educational institution.
